The Society has now been in The Kiosk for a year and it has been transformed into a community space to be enjoyed by our members, partners in The Kiosk and members of the public.

Our partnership with The Friends of the Christchurch Botanic Gardens was a great help with achieving the lease and their steady help with volunteers on Friday and Sunday every week has been a great benefit to the CHS.

Our most recent partnership with The Christchurch Enviro Hub has also brought many benefits to the CHS by supplying volunteers when we need them, adding more interesting displays to The Kiosk and planning future activities to enhance our



presence in the Christchurch Botanic Gardens.

The signage for The Kiosk is almost completed with only the Christchurch Enviro Hub to finalise their art work to be added to the external sign. The flags attract attention and more signs are in the pipeline to advertise exhibitions and shows as they occur.

The Kiosk Calendar is filling up with many regular activities, exhibits and workshops planned by ourselves and our partners and all are available to our Members as of right to attend. These events are advertised in the monthly newsletter and on the CHS and Botanic Gardens websites and Facebook pages.

Improvements to the building have taken quite a while to complete, however, we now have a very compact but efficient kitchen at our disposal which enhances our ability to attract more activities into The Kiosk. and monitors which will help with ease of use.

At this stage, with another 4 years to run of the current lease we are in a good position to look ahead and plan for the future of the Society.

FINANCIAL PERFORMANCE SUMMARY

The 2019 year highlights were:

Total revenue was reduced due to no longer selling garden tours and a reduction (\$65,000) in the requirement to cash in some of our investments. It should be noted that Subscriptions, our basic income were \$17,513 (2018 \$19,437 and 2017 \$22,669) and with membership dropping by 106 to 362 at year end.

Total expenditure was \$178,520 (2017 \$448,000)

with the cost of the Garden Tours being mainly responsible for the difference.

The Operating Loss for the year was \$62,879 which was greater than the 2018 loss of 29,000 and includes the write down of our remaining trophies at a cost of \$6,476.

The capital expenditure relates to the lease of The Kiosk and improvements to the Kitchen and a new Computer for the Office Manager.

The total equity at 31 December 2018 was \$2,049,150 (2017 \$2,112,000).

The ANZ investments are split between an Income Portfolio (\$816,000 31/12/19) and a Growth Portfolio (\$1,206,000 31/12/19) and during the year we drew down \$135,000 from the investments (6.4% of our opening equity) to support the cash flow required to operate the Society. The overall investment returns for the 2019 year were, after deducting fees,



24.59% for the Growth Portfolio and 14.43% for the Income Fund. The total investments of \$2,380,530 at 31/12/19 include unrealised gains (i.e. not cashed up) of \$220,000 for the Growth Fund and \$139,000 for the Income Fund.

The Coronavirus Pandemic and resulting falls in the worlds share markets will mean a significant reduction in the equities balances for the first quarter of 2019 although the ANZ expects a general bounce back over time.

The preparation of the Annual Accounts was assisted by Ainger Tomlin and independently audited by Ashton Wheelens with no significant issues being raised.
